I _____ (Print participants full name), hereby RELEASE, WAIVE, DISCHARGE and COVENANT NOT TO SUE STABLE FOUNDATIONS LLC, Douglas, Cassi, Emma, Ethan, Everett or Evelyn Sanford, nor any agents of or employees (hereinafter referred to as RELEASES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage or injury, including death that may be sustained by me or to any property belonging to me, however caused, while participating on, or while in, any premises of Stable Foundations LLC property.

I am fully aware of the risks and hazards connected with participating in the activities with horses and/or any other animals on Stable Foundations LLC premises. I acknowledge that horses and other animals are unpredictable and potentially dangerous animals. I understand Stable Foundations LLC provides only limited, restricted or no insurance coverage.
